# LEGAL ENGLISH

## COURSE DESCRIPTION

English is the language of communication in the modern legal community. Step inside renowned legal institutions and experience justice in action. In London, visit the famous Central Criminal Court (the Old Bailey), the Royal Courts of Justice and the British Library, home to one of the original copies of the Magna Carta. In Toronto, visit the Ontario Court of Justice, and in New Zealand, explore the Auckland District Court. Field trips are scheduled every two weeks to complement and enhance classroom learning.

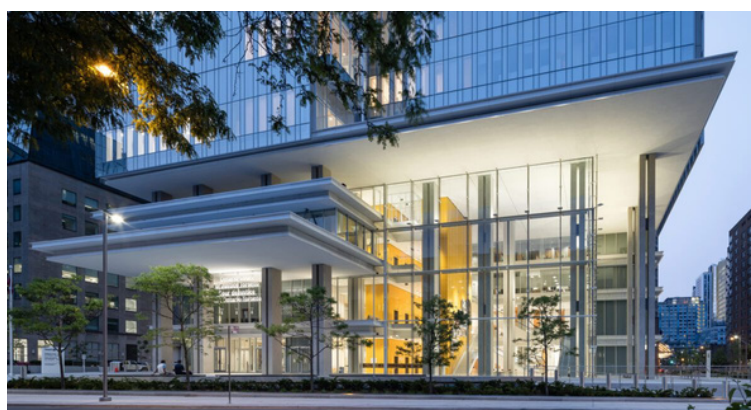
